### About the Role

As a Women's Employment Counsellor, you'll provide one-to-one and group-based support to survivors of gender-based violence, supporting their goals to re-enter the labour market or pursue meaningful, community-connected economic options. You'll offer trauma and violence-informed employment counselling, develop curriculum and facilitate employment readiness workshops, and guide survivors in identifying and building on their strengths, skills, and career goals.

#### What You'll Do

- Deliver individualized case management, including intake assessments, safety planning, employment counselling, and referrals
- Plan and deliver group workshops through the AWARE Program, including life skills, essential skills, job search, and employment readiness

- Support women in developing and implementing action plans for employment and/or community connection
- Develop and maintain comprehensive case files, client notes, and data entry in the BC Integrated Case Management (ICM) system
- Provide coaching that helps women recognize their values, interests, and aptitudes related to employment
- Liaise with external service providers to support wraparound care and community-based supports
- Contribute to curriculum design and workshop content that supports participants' emotional, psychological, and economic needs

## What You Bring

- A minimum of two years of experience providing direct support to women survivors of genderbased violence
- A minimum of five years of combined training and education in employment counselling, social work, women's studies, or related fields
- Knowledge of the dynamics of gender-based violence, trauma and violence-informed practices, and the intersections between violence and economic insecurity
- Experience in formal needs assessments, employment counselling, and coaching survivors in goal development
- Skilled in developing and facilitating workshops on job readiness, essential life skills, personal management, and career development
- Administrative strengths, including recordkeeping, case notes, and database use (experience with BC's ICM database is a strong asset)
- Strong communication, collaboration, and facilitation skills
- A passion for social justice, community building, and ending gendered economic oppression.
